(b) Specific Experience	The Bidder shall demonstrate that it has successfully completed at least two (02) projects within the last five (05) years prior to the bid submission deadline, each with a value of at least PKR 200 million . These projects must have been successfully and substantially completed and must be similar/comparable in nature and complexity to the Goods and Related Services under this RFB. For a joint venture, either member or the combined entity can fulfill this requirement.	The Bidder shall demonstrate that it has successfully and substantially completed at least three (03) contracts within the last five (05) years prior to bid submission deadline, of similar nature and complexity to the Goods and Related Services having cumulative value of PKR 400 million . Out of the three (03) contracts, one (01) contract, exclusively, should have value of PKR 100 million . For a joint venture, either member or combined can full fill this condition.
