

2. Firms must fulfill the following requirement:

- Interested and eligible firms shall submit their applications online via PPRA's e-PADS Portal at <https://epads.ppra.org.pk> no later than **04 September, 2025 at 12:30 PM**, or within (15) days of the advertisement's publication on PPRA's website, whichever is later.
- Only GST/NTN-registered firms based in **Islamabad or Rawalpindi** are eligible to submit their bids on e-PADS portal.
- Bidders must submit an affidavit on Judicial Stamp Paper affirming that the firm has not been blacklisted by any government or semi-government organization.
- A formal application, on the bidding firm's official letterhead, along with a Call Deposit Receipt (CDR) amounting to **Rs. 684,000/-** in favor of the Assistant Collector (HQ), Collectorate of Customs Enforcement, Islamabad, must be submitted to the Assistant Collector (HQ), Collectorate of Customs Enforcement, Islamabad.
- Bids will be opened on the same day, **04 September, 2025 at 02:00 PM**, in the presence of the participating bidders.
- Successful bidders must supply the required uniforms and protective clothing for the fiscal year 2025-2026 within (15) days of issuance of the purchase order.
- Failure to supply within the stipulated period will result in forfeiture of the Call Deposit and cancellation of the order.
- All quoted rates must be inclusive of all applicable government duties and taxes.
