

2. Firms must fulfill the following requirements:

- Interested and eligible firms must submit their applications online via PPRA's e-PADS Portal: <https://epads.ppra.org.pk> by **21.08.2025 at 12:30 PM** or within 15 days of the advertisement's publication on PPRA's website, whichever is later.
- Only GST/NTN registered firms from **Islamabad/Rawalpindi** are eligible to submit their bids on e-PADS.
- An affidavit of no backlisting must be submitted on Judicial Stamp Paper.
- An application must be submitted to Assistant Collector (HQ), Collectorate of Customs Enforcement Islamabad, on the letter head of the bidding firm along with a CDR in the name of Assistant Collector (HQ), Collectorate of Customs Enforcement Islamabad, amounting to **Rs. 60,000/-** as Call Deposit Receipt (CDR).
- Bids shall be opened at **02:00 PM** on the same day, **21.08.2025**, in the presence of bidders.
- Successful bidders must supply the miscellaneous items during year 2025-26 within 15 days of the purchase order. Failure to do so will result in the forfeiture of the Call Deposit, and the order shall stand cancelled.
- Quoted rates should be inclusive of all applicable government duties and taxes.
