- ii. Procedure of opening Bids will be upon as single stage, two envelopes basis.
- iii. The tender document (s) can be obtained from **Chief Accounts Officer**, Collectorate of Customs (Enforcement), Custom House, Quetta on cash payment of **Rs.2,000/- (non-refundable)** during office hours from **15-09-2025 to 19-09-2025**.

Terms and Conditions

- The tender shall be granted on the basis of competitive bidding process, as is embodied in Public Procurement Rules, 2004.
- The bidder should be registered with Income Tax, Sales Tax, having their own office & Phone / fax numbers (if found contrary, the tender will be rejected).
- The bidders should not have been black-listed by any authority in the past.
- The bidders are required to furnish security deposit of 2% of total amount in the shape of pay order or demand draft from a scheduled bank in favor of the **Collector, Collectorate of Customs Enforcement, Custom House, Quetta**. The Security deposit shall be refunded to the unsuccessful bidder(s). The Security Deposit shall be returned to the successful bidder on completion of the tender contract.
- The price shall be offered in local currency and include all duties/ taxes and the expenses incurred on supplies including transportation, labor etc. where required up to 30-06-2026.
- The tender bid must mention the type of warrantee and after sale services, if any.
- Sealed tender bids on prescribed tender documents must be delivered to the address given below on **25-09-2025**, before **12:00 pm** and the same shall be opened at **01:00 pm** on the same day in the presence of the participants of the tender or their authorized representatives who desire to attend.

- viii. Bidder shall quote their final prices both in figures and in words, any cutting / overwriting and correction in the tender form will not be accepted.
- ix. Bidders are required to give complete description, catalogue of items along with samples of their offers.
- x. The tender bid must be valid for up to 30-06-2026, after opening of tenders.
- xi. Payments will be made on the basis of verification / inspection by concerned staff and subsequent report submission.
- xii. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall, upon request, communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposal, but is not required to justify those grounds.
- xiii. The procuring agency shall announce the results of bid evaluation in the form of a report giving justification for acceptance or rejection of bids at least three days prior to the award of procurement contract. A copy of the result shall be placed on the notice board of Collectorate of Customs (Enforcement), Custom House, Quetta
