**TENDER NOTICE FOR SUPPLY OF RATION

Sealed tenders are invited from reputed suppliers, contractors, or firms registered with Income Tax and Sales Tax Departments for the supply of dry and perishable ration items required for the check posts operating under the jurisdiction of the Collectorate of Customs Enforcement, Gadani, for the Financial Years 2025-26.

SCOPE OF WORK

The successful bidder shall be responsible for the supply and delivery of ration items (dry and perishable) as per the approved list to various Customs Check Posts/Field Formations situated within the jurisdiction of the Collectorate, including but not limited to:

Terms & Conditions

i. **Submission & Opening of Bids**

Sealed bids must be dropped in the Tender Box placed in the Administration Branch, Collectorate of Customs Enforcement, Gadani, on or before **9th February, 2026** up to **1400 hours**. The bids shall be opened on the same day at **1500 hours** in the presence of the bidders or their duly authorized representatives who may wish to witness the opening of the sealed tenders.

ii. **Mandatory Documents**

The following documents must be attached with the tender documents; otherwise, the bid shall be considered non-responsive:

- Copy of valid Sales Tax Registration (FBR)
- Copy of valid Provincial Sales Tax Registration, issued by the relevant provincial authority, such as:
 - Balochistan Revenue Authority (BRA)
 - Sindh Revenue Board (SRB)
 - Punjab Revenue Authority (PRA)
 - Khyber Pakhtunkhwa Revenue Authority (KPRA)
- Copy of valid Income Tax Registration (NTN)
- Business profile for the last three (03) years
- Authority letter showing details of the authorized person for each administrative division
- Copy of CNIC of the authorized person
- Affidavit on stamp paper confirming that the firm/company is not blacklisted by any government or semi-government organization

iii. **Right of Acceptance / Rejection**

The competent authority reserves the right to accept or reject any or all bids in accordance with the provisions of Rule-33 of PPRA Rules, 2004.

iv. **Modification of Bids**

No bidder shall be allowed to alter, amend, or modify his/her bid after the opening of bids.

v. **Conditional Bids**

Conditional bids shall not be accepted.

vi. **Samples / Specifications**

Complete details/specifications of all quoted items must be attached with the tender/bid; otherwise, the bid shall not be considered.

vii. **Taxes**

Quoted rates must be inclusive of all applicable federal, provincial, and local taxes, duties, and levies.

viii. **Call Deposit (Bid Security)**

Each bid must be accompanied by a call deposit equivalent to 2% of the estimated cost in the form of a Pay Order in favor of: **Collector, Collectorate of Customs Enforcement, Gadani**

ix. **Validity of Rates**

The quoted rates shall remain valid for a period of six (06) months and may be revised thereafter, subject to mutual agreement, keeping in view market fluctuations and inflation/deflation.

x. **Incomplete Quotations**

Incomplete quotations or bids lacking any required document or information shall not be considered under any circumstances.

xi. **Performance Security/Guarantee:**

After signing of contract agreement, the successful bidder (s) within 10 days shall submit to the Collectorate a Performance Guarantee equivalent to 5% of the estimated amount of contract in the shape of Pay order having validity till 30th June, 2026 from a schedule bank of Pakistan or AA rating insurance company. After the verification of performance guarantee submitted by the successful bidder, the firm(s) bid security instrument shall be released.


