

## **PREFACE**

Public Procurement is carried out in Pakistan in accordance with the provisions laid down in Public Procurement Regulatory Framework consisting of Public Procurement Ordinance- 2002; Public Procurement Rules-2004 and allied Regulations, Regulatory Guides and Guidelines.

National Standard Bidding/Procurement Documents are developed for standardizing the procurement procedures and practices in the procuring agencies of the Federation of Pakistan and has the status of the Regulations in terms of section 27 of the PPRA Ordinance read with Rule-23(4) of Public Procurement Rules.

The document consists of general as well as specific provisions to be applicable for the procurement of Information Systems. The specific provisions supplement to the general provisions and may be amended or opted by the procuring agencies in the manner and to the extent prescribed in the respective sections.

This Section includes provisions specific to procurement and to supplement Section-II, Instructions to Bidders. This section may be customized where option is available, in accordance with the requirements of the Procuring Agency.

### **Section IV - Eligible Countries**

This Section contains information regarding eligible countries.

### **Section V - Technical Specifications, Schedule of Requirements**

This Section includes the details of specifications for the goods and ancillary services to be procured and schedule of requirements.

### **Section VI - Standard Forms**

This Section includes the standard forms for the Bid Submission, Price Schedules, and Bid Security etc. These forms are to be completed and submitted by the Bidder as part of - Bid.

## **PART-B - CONDITIONS OF CONTRACT AND CONTRACT FORMS**

### **Section VII - General Conditions of Contract (GCC)**

This Section includes the general clauses to be applied in all the contracts. *This Section contains provisions those are to be used without modifications.*

### **Section VIII - Special Conditions of Contract (SCC)**

This Section consists of Contract Specific general and special conditions. The procuring agency may customize the general conditions of the contract section, in accordance with the requirements.

## **Section IX - Contract Forms**

This Section contains forms which, once completed, will become part of the Contract. The forms for **Performance Security** will be submitted by the successful bidder to whom Letter of Acceptance is issued, before the award of contract.

For products identified in the OPE section of the Annual Services Exhibit and documented in FBR Environment and Configuration Guide, the TAM and ASE(s) are the designated points of contact for Severity 1 and mutually agreed upon Severity 2 SRs, collectively (“critical SRs”) and shall provide the following support Services for the quantity of Full Coverage Units defined in the OPE section of the Annual Services Exhibit:

- (i) Conduct SR analysis.
- (ii) Assist with issue identification and issue reproduction.
- (iii) Assist with constructing a reproducible test case required by Oracle Support Services to address an SR and help determine a workaround for the issue.
- (iv) Assist with potential workarounds.
- (v) Provide guidance to implement the recommendations documented in the SR.
- (vi) Assist with testing prior to production implementation of any recommendations.
- (vii) Extract data from a downed database and attempt a recovery for Oracle databases within the OPE section of the Annual Services Exhibit;
- (viii) Provide advice and recommendations regarding the operation, configuration and use of the applicable Oracle Support Services tools for FBR Oracle products in the OPE section of the Annual Services Exhibit; and

- (ix) Notify FBR Oracle alerts, releases, firmware updates and patches related to Your Oracle products in the OPE section of the Annual Services Exhibit, including critical patch updates.

**b. Critical Reactive Service Requests**

If FBR order includes products identified in the OPE section of the Annual Services Exhibit and documented in FBR Environment and Configuration Guide as Critical Reactive units as defined in the Annuals Exhibit, Oracle will monitor only Severity 1 and mutually agreed upon Severity 2 SRs and communicate the SR status to FBR designated Customer Contacts for the quantity of Critical Reactive units defined in the OPE section of the Annual Services Exhibit.

**c. Service Request Prioritization**

Oracle will prioritize FBR SRs above SRs of the same severity level submitted by other Premier Support customers. Reasonable efforts will be made to respond to FBR SRs per the following guidelines (“SR Response Guidelines”):

- n. 90% of Severity 1 SRs within one (1) hour local business hours.
- o. 90% of Severity 2 SRs within two and one half (2.5) local business hours.
- p. 90% of Severity 3 SRs within the next local business day; and
- q. 90% of Severity 4 SRs within the next local business day.

**Reconfiguration of Oracle Audit Vault Configuration & Database Firewall (AVDF)**

Oracle is responsible for reconfiguring the Oracle Audit Vault and Database Firewall (AVDF) for databases migrated to the new Exadata infrastructure and will be reapplying existing audit policies and alerts to the in-scope databases.

As part of the migration of in-scope databases to the new Exadata platform, the following activities will be performed as part of Oracle Audit Vault and Database Firewall (AVDF) configuration to make it fully operational, compliant with existing audit policies, and aligned with security monitoring requirements.

#### **Installation and Configuration of AVDF Agents on New Exadata**

Deploy and configure Oracle AVDF Agents on each of the newly migrated database nodes hosted on the new Exadata platform.
