4. The quotation must be valid for at least 30 days from the submission date and the quoted price should include all the applicable taxes, on DDP (Delivery Duty Paid) base with segregation of taxes for FBR HQs, Islamabad.

5. Submission of rates/quotations shall constitute acceptance of all terms and conditions, including delivery requirements, inspection rights, warranty obligations, and applicable laws of Pakistan and shall be subject to applicable anti-corruption provisions and audit/inspection rights. The offered product must be from a reputable international manufacturer with verifiable warranty support in Pakistan.
