

MINUTES OF THE PRE -BID MEETING

SUBJECT: HIRING OF ACCREDITED ACADEMIC INSTITUTION FOR CONDUCTING RECRUITMENT PROCESS OF GOODS EVALUATORS ON CONTRACT BASIS ON A FIXED LUMP-SUM MONTHLY SALARY PACKAGE FOR YEARS 2026-27, 2027-28 & 2028-29

To hire the services of Accredited Academic Institutions for Conducting Recruitment Process of Goods Evaluators on Contract Basis on a Fixed Lump-sum Monthly Salary Package for years 2026-27, 2027-28 & 2028-29, an advertisement was floated in Daily "Ausaf" and daily, "The News" on 30.01.2026 (Friday). The advertisement was also published on FBR and PPRA websites. The bidding documents were also uploaded on e-Pads and FBR websites. The VLC link was provided in the advertisement for the firms to participate in the meeting online. As per PPRA Rules, 2004, a pre-bid meeting (in person and online) in Committee Room No.358 was convened on 04.02.2026 at 11:00 am. The Secretary to Procurement Committee alongwith Mr. Isfandyar Ikram Khan, Second Secretary Transformation Delivery Unit (TDU) were present (**Annex-A**).
