- Valid NTN Certificate from Federal Board of Revenue (Should be an Active Taxpayer)
- Valid Sales Tax Certificate from Sales Tax Authorities/Sindh Revenue Board (SRB).
- Provided affidavit that the firm is not Blacklisted or engaged in any Litigation on any project by any organization.
