6. A Pre-Bid Meeting shall be held on **1st June 2026 at 15:00 hours (PST)** in FBR House, Constitution Avenue, Islamabad to address any queries of the interested bidders. Further details regarding the Pre-Bid Meeting are provided in the Request for Bids (RFB) document.
7. Bids must be delivered to the address below on or before **11:30 AM** dated **10th June 2026**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **10th June 2026** immediately after the bid submission deadline.

All Bids must be accompanied by a bid security in shape of "Pay Order/ Demand Draft/ Call Deposit Receipt" or "Bank Guarantee" of **PKR Three million only (PKR 3,000,000/-)** issued by a scheduled Bank located in Pakistan, as per the details/ requirements given at the respective section(s)/ clause(s), or the equivalent amount in any freely convertible currency.
