- c) Time: **1100 HRS PST**

Opening of Technical Proposals (ITP 26.1):

- a) Day: **Tuesday**
- b) Date: **14<sup>th</sup> July, 2026**
- c) Time: **1130 HRS PST**

3. Pursuant to ITP 8 (Amendment of the Request for Proposals Document), all consequential dates linked to the Proposal Submission Deadline are hereby revised accordingly.

In particular, the Proposal Data Sheet (PDS) provisions under ITP 19.1 (Proposal Validity) and ITP 36.2 (Exchange Rate Date for Proposal Evaluation) shall be read as follows:

**ITP 19.1**

The Proposal shall be valid until **10 January 2027**.

**ITP 36.2**

The date for the exchange rate shall be the **Selling Rate prevailing on 30 June 2026**, being fourteen (14) days prior to the revised Proposal Submission Deadline.

4. This Addendum shall form an integral part of the Request for Proposals (RFP). All Proposers shall take this Addendum into account while preparing and submitting their Proposals.

5. All other provisions, terms and conditions of the Request for Proposals (RFP) shall remain unchanged and shall continue to apply.
