Bidding will be conducted through National competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” Fifth Edition September 2023 (“Procurement Regulations”) and is open to all eligible Bidders as defined in the Procurement Regulations.

7. Bids must be delivered to the address below on or before **11:30 AM** dated **20th August 2026**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **20th August 2026** i.e. immediately after the bid submission deadline.

All Bids must be accompanied by a bid security in shape of "**Pay Order/ Demand Draft/ Call Deposit Receipt**" or "**Bank Guarantee**" of **PKR Four Million, Three hundred seventy five thousand Only (PKR 4,375,000/-)** issued by a scheduled Bank located in Pakistan, as per the details/ requirements given at the respective section(s)/ clause(s).
