PART-B – CONDITIONS OF CONTRACT AND CONTRACT FORMS

Section VII - General Conditions of Contract (GCC)

This Section includes the general clauses to be applied in all the contracts. This Section contains provisions those are to be used without modifications.

Section VIII - Special Conditions of Contract (SCC)

This Section consists of Contract Specific general and special conditions. The FBR may customize the general conditions of the contract section, in accordance with the requirements.

Section IX - Contract Forms

This Section contains forms which, once completed, will become part of the Contract. The forms for **Performance Guarantee** will be submitted by the successful bidder to whom Letter of Acceptance is issued, before the award of contract.

Integrity Pact

The successful bidder shall be required to furnish Integrity Pact as per the attached format.

SECTION I: INVITATION TO BIDS

Bid No. 1(9)TDU/IR/2026

A. INVITATION TO BID

**[AUTHORIZED VENDORS FOR SUPPLY, INSTALLATION AND MAINTENANCE OF
PRODUCTION MONITORING SYSTEM IN HATCHERIES SECTOR
(Three years from authorization)]**

1. The Federal Board of Revenue (FBR) invites sealed bids from eligible vendors, registered with PPRA on e-PADS and with the relevant tax authorities, for the supply, installation, integration, commissioning and maintenance of a standardized Production Monitoring and Day-Old Chick (DOC) Counting Solution based on Box/Tray/Crate-Based Verification across commercial poultry hatcheries in Pakistan, in accordance with the Sales Tax Act, 1990, Sales Tax Rules, 2006 and applicable procurement laws and rules.

The procurement is being undertaken as Stage Two of the Two-Stage Bidding Procedure. Stage One of the procurement, including technical evaluation, Proof of Concept (POC), technical discussions and assessment of alternative technological approaches, has already been completed. Based on the outcome of Stage One and operational requirements, FBR has finalized the required solution architecture for Stage Two.

The Stage-Two solution shall provide automated verification of standardized chick trays, boxes or crates at the designated packing/dispatch point and determination of the corresponding number of Day-Old Chicks (DOCs) based on the approved packing configuration. The solution shall provide secure transmission of production data to FBR and a web-based dashboard for real-time monitoring, reporting, reconciliation and audit.

2. The vendors are required to submit proposals for the finalized Box/Tray/Crate-Based Production Monitoring and Day-Old Chick (DOC) Counting Solution, comprising, at a minimum:
 - Automated identification and verification of standardized chick trays, boxes or crates at designated packing/dispatch points;
 - Automated determination of the corresponding number of DOCs based on the approved packing configuration associated with each verified tray, box or crate;
 - Recording of each production/dispatch event with appropriate date, time, hatchery, production point and other prescribed identifiers;
 - Secure local processing, buffering and transmission of production data to FBR;
 - A web-based dashboard providing authorized FBR users with real-time visibility of production events, production quantities, system status, alerts, analytics and audit information;
 - Tamper-resistant and audit-ready records, including appropriate logs, video/electronic evidence where applicable, and system-generated alerts for device failure, obstruction, connectivity failure or other abnormal conditions; and

- All hardware, software, networking, computing, storage, cybersecurity, integration, installation, commissioning, training, maintenance and support necessary for an end-to-end operational solution.

The proposed solution shall meet the mandatory technical requirements, Technical Evaluation Criteria and Stage-Two POC criteria specified in Section V of this RFP.

3. The Bidding documents are available on e-PADS and FBR/PPRA Websites i.e. <https://www.ppra.gov.pk> & <https://www.fbr.gov.pk/> and can be downloaded free of cost. Encrypted electronic bids duly completed and in conformity with Bidding Documents must be submitted online on e-Pak Acquisition and Disposal System (e-PADS) website on or before 02:00 PM by 14th September 2026.
4. The instant procurement for authorized vendors is being carried out under Public Procurement Rules, 2004 and E-Pak-Procurement Regulations, 2023 read with PPRA Public Procurement Framework. Procurement structure has been designed keeping in view Rule 4 and other relevant provisions under PPR, 2004 including but not limited to provisions as referred at Rule 15, Rule 21, Rule 29 and the rules connected thereto. The translation of the relevant provisions of PPR, 2004 into procurement design/structure has been made part of the instant bidding document.
5. The instant procurement is being conducted as **Stage Two of the Two-Stage Bidding Procedure** under the applicable PPRA Rules.
 - a. Stage One of the procurement has already been completed. During Stage One, bidders submitted technical proposals, participated in technical evaluation and conducted Proof of Concept tests. FBR subsequently assessed the technological approaches and operational feasibility of the solutions.
 - b. In Stage Two, all eligible bidders shall submit revised Technical Proposals against the finalized technical requirements specified in this RFP, together with revised financial proposals or supplementary financial proposals to their previously submitted financial proposals, as applicable, in accordance with the PPRA Rules and the requirements of this RFP.
 - c. The revised proposal shall relate exclusively to the Box/Tray/Crate-Based Verification Solution finalized by FBR for determination of Day-Old Chick production at the packing/dispatch stage.
 - d. Eligible bidders shall conduct a final Proof of Concept (POC) of the finalized solution at one designated installation point in accordance with the POC criteria prescribed in Section V.
 - e. Bidders qualifying the prescribed technical evaluation and POC requirements shall be considered for authorization in accordance with the evaluation methodology and other provisions of this RFP.

No alternative production-monitoring methodology, including hatch-cycle-based production determination or direct live-chick counting as the primary production-determination mechanism, shall be considered in Stage Two.

6. Accordingly, only the bidders declared technically responsive in Stage One are eligible to participate in this Stage. Eligible bidders shall submit revised technical proposals, where required, together with revised or supplementary financial proposals in accordance with the finalized solution and the requirements of this RFP.
7. The proposals shall be evaluated against the technical, functional and financial requirements specified in this RFP, following which FBR shall authorize the successful bidders for deployment of the finalized Production Monitoring System.
8. In order to brief the eligible bidder about the project details and address the queries on the Bidding Document and suggestive improvements, a Pre- Bid Meeting will be held on **4th September, 2026 at 02:30 PM.** in Room 358, 3rd Floor, FBR House, Constitution Avenue, G-5, Islamabad. 9. The original bids (e-PADS Tender Prints) along with 2 copies, properly filled in, and enclosed in sealed envelopes must be delivered to the address, Room 510, Fifth Floor, Floor, FBR House, Constitution Avenue, G-5, Islamabad, **on or before 02:00 PM by 14th September 2026.** E-bids will be opened on the same day **at 02:30 PM in the** presence of bidders' representatives who choose to attend in Room 358, 3rd Floor, FBR House, Constitution Avenue, G5, Islamabad. Submission of manual bids without submissions on EPADS shall be rejected.
10. FBR may reject all bids at any time prior to the acceptance of a bid by invoking rule 33 of Public Procurement Rule (PPR), 2004.

SECTION II: INSTRUCTION TO BIDDERS (ITBs)

A. INTRODUCTION

1. Scope of Bid	1.1	The FBR (PA), as indicated in the Bid Data Sheet (BDS), invites Bids for the Authorization of Vendors to supply, install, and maintain a production monitoring and day-old chick (DOC) counting system (AI-based Vision Analytics for Tray Counting and Verification (as an approximation of Day-Old Chick output) or equivalent validated technologies), provided that the proposed solution meets both the Technical and Proof of Concept (POC) evaluation criteria defined in Section V – Scope of Work, across poultry hatcheries in Pakistan, as specified in the BDS and Section V – Scope of Work.
	1.2	Unless otherwise stated throughout this document definitions and interpretations shall be as prescribed in the General Conditions of the Contract (GCC).
2. Source of Funds	2.1	Source of funds for launching this intervention has been stated in Clause 2 of Section III - Bid Data Sheet
3. Eligible Bidders	3.1	Public sector or Government-owned enterprises are not eligible to participate and only bidders who have successfully qualified in Stage One of the bidding process shall be eligible to participate in Stage Two. Other conditions of the eligibility criteria as specified in Stage I RFP remain the same.
	3.2	A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they: a) are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the FBR to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of the information systems to be procured under this Invitation for Bids. b) have controlling shareholders in common; or c) receive or have received any direct or indirect subsidy from any of them; or d) have the same legal representative for purposes of this Bid; or e) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of

		another Bidder, or influence the decisions of the FBR regarding this Bidding process; or f) Submit more than one Bid in this Bidding process. g) Vendors having Commercial relationships with monitored manufacturers h) Vendors having equity, revenue sharing, or consultancy links with monitored manufacturers
	3.3	A Bidder may be ineligible if – (a) he is declared bankrupt or, in the case of company or firm, insolvent; (b) payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property; (c) legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property; (d) the Bidder is convicted, by a final judgment, of any offence involving professional conduct; (e) the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or performance failure or due to breach of bid securing declaration. (f) The bidder is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them.
	3.4	Bidders shall provide to the FBR evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.
	3.5	Bidders shall provide such evidence of their continued eligibility to the satisfaction of the FBR, as the FBR shall reasonably request.
4. Eligible Information Systems	4.1	For the purposes of these Bidding Documents, the Information System means all: a) the required information technologies, including all information processing and communications-related hardware, software, supplies, and consumable items that the

		bidder is required to supply and install under the Contract, plus all associated documentation, and all other materials and goods to be supplied, installed, integrated, and made operational (collectively called “the Goods” in some clauses of the ITB); and b) the related software development, transportation, insurance, installation, customization, integration, commissioning, training, technical support, maintenance, repair, and other services necessary for proper operation of the Information System to be provided by the successful Bidder and as specified in the Contract.
	4.2	All Information System made up of goods and services to be supplied shall have their origin in eligible source countries. For purpose of this Bid, ineligible countries are stated in the section IV titled as “Eligible Countries”.
	4.3	For purposes of this Clause, “origin” means the place where the goods and services making Information System are produced in or supplied from. An Information System is deemed to be produced in a certain country when, in the territory of that country, through software development, manufacturing, or substantial or major assembly or integration of components, a commercially recognized product result that is substantially different in basic characteristic or in purpose or utility from its component.
	4.4	The nationality of the bidder that supplies and install the Information System shall not determine the origin of the goods.
	4.5	To establish the eligibility of the Goods and Services making Information System, Bidders shall fill the country-of-origin declarations included in the Form of Bid.
	4.6	If so required in the BDS , the Bidder shall demonstrate that it has been duly authorized for the supply and installation of Information System in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the Information System indicated in its Bid.
5. One Bid per Bidder	5.1	A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.
	5.2	No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.

	5.3	A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.
6. Cost of Bidding	6.1	The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the FBR shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

B. BIDDING DOCUMENTS

7. Contents of Bidding Documents	7.1	The Contents of the Bidding Documents listed below should be read in conjunction with any addenda issued in accordance with ITB 9.2 include: Section I -Invitation to Bids Section II Instructions to Bidders (ITBs) Section III Bid Data Sheet (BDS) Section IV Eligible Countries Section V Scope of Work Section VI Standard Forms Section VII General Conditions of Contract (GCC) Section VIII Special Conditions of Contract (SCC) Section IX Contract Forms
	7.2	The number of copies to be completed and returned with the Bid is specified in the BDS .
	7.4	The FBR is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the FBR or the signed pdf version from downloaded from the website of the FBR. However, FBR shall place both the pdf and same editable version to facilitate the bidder for filling the forms.
	7.5	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder's risk and may result in the rejection of his Bid.
8. Clarification of Bidding Documents, Pre-Bid Meeting and Site Visit	8.1	A prospective Bidder requiring any clarification of the Bidding Documents may notify the FBR in writing or in electronic form that provides record of the content of communication at the FBR's address indicated in the BDS .
	8.2	The FBR will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in ITB 21.1 .

	8.3	Copies of the FBR's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source. In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.
	8.4	Should the FBR deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB 9.
	8.5	If indicated in the BDS, the Bidder's designated representative is invited at the Bidder's cost to attend a pre-Bid meeting at the place, date and time mentioned in the BDS. During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.
	8.6	Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the FBR exclusively through the use of an Addendum pursuant to ITB 9. Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.
	8.7	The Bidder may wish to visit and examine the site or sites of the Information System and obtain for itself, at its own responsibility and risk, all information that may be necessary for preparing the bid and entering the Contract. The costs of visiting the site or sites shall be at the Bidder's own expense.
	8.8	The FBR will arrange for the Bidder and any of its personnel or agents to gain access to the relevant site or sites, provided that the Bidder gives the FBR adequate notice of a proposed visit of at least seven (07) days. Alternatively, the FBR may organize a site visit or visits concurrently with the pre-bid meeting, as specified in the BDS for ITB Clause 8.5. Failure of a Bidder to make a site visit will not be a cause for its disqualification
	8.9	No site visits except POC visits shall be arranged or scheduled after the deadline for the submission of the Bids and prior to the award of Contract.

9. Amendment of Bidding Documents	9.1	Before the deadline for submission of Bids, the FBR for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-bid meeting may modify the Bidding Documents by issuing addenda.
	9.2	Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to ITB 7.1 and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the FBR. The FBR shall promptly publish the Addendum at the FBR's web page identified in the BDS: Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.
	9.3	To give prospective Bidders reasonable time in which to take an addendum/corrigendum into account in preparing their Bids, the FBR may, at its discretion, extend the deadline for the submission of Bids: Provided that the FBR shall extend the deadline for submission of Bid, if such an addendum is issued within last three (03) days of the Bid submission deadline.

C. PREPARATION OF BIDS

10. Language of Bid	10.1	The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the FBR shall be written in the English language unless otherwise specified in the BDS. Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the BDS, in which case, for purposes of interpretation of the Bidder, the translation shall govern.
11. Documents Constituting the Bid	11.1	The Bid prepared by the Bidder shall constitute the following components: - i) Technical Proposal with complete details of the finalized Box/Tray/Crate-Based Verification Solution, including the proposed configuration for one installation point and the indicative price per installation point, together with a

		component-wise price breakdown as prescribed in the Price Schedule2; ii) Details of the Sample(s) where applicable and requested in the BDS. iii) Documentary evidence established in accordance with ITB 13 that the Bidder is eligible and/or qualified for the subject bidding process; iv) Documentary evidence established in accordance with ITB 13.3(a) that the Bidder has been authorized by the manufacturer to deliver the goods and services making Information System into Pakistan, where required and where the bidder is not the manufacturer of those goods and service making Information System; v) Documentary evidence established in accordance with ITB 12 that the goods and services making Information System to be supplied by the Bidder are eligible, and conform to the Bidding Documents; vi) Bid security or Bid Securing Declaration furnished in accordance with ITB 16; vii) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid; and viii) Any other document required in the BDS.
12. Documents Establishing Eligibility of the Information System and Conformity to Bidding Documents	12.1	Pursuant to ITB 11 , the Bidder shall furnish, as part of its Bid, all those documents establishing the eligibility in conformity to the terms and conditions specified in the Bidding Documents for all goods and services related to the information system which the Bidder proposes to deliver.
	12.2	The documentary evidence of conformity of the goods and services related to the Information Systems to the Bidding Documents may be in the form of literature, drawings, and data, and shall consist of:

26. Clarification of Bids	26.1	To assist in the examination, evaluation and comparison of Bids of the Bidders, the FBR may, ask any Bidder for a clarification. Any clarification submitted by a Bidder that is not in response to a request by the FBR shall not be considered.

	26.3	The alteration or modification in THE BID which in any affect the following parameters will be considered as a change in the substance of a bid: a) evaluation & qualification criteria; b) required scope of work or specifications; c) all securities requirements; d) tax requirements; e) terms and conditions of bidding documents. f) change in the ranking of the bidder
	26.4	From the time of Bid opening to the time of authorization if any Bidder wishes to contact the FBR on any matter related to the Bid it should do so in writing or in electronic forms that provide record of the content of communication.
27. Preliminary Examination of Bids	27.1	Prior to the detailed evaluation of Bids, the FBR will determine whether each Bid: a) meets the eligibility criteria defined in ITB 3 and ITB 4;

A material deviation or reservation is one that: - a) affects in any substantial way the scope, quality, or performance of the Services; b) limits in any substantial way, inconsistent with the Bidding Documents, the FBR's rights or the Bidders obligations under the Contract; or c) if rectified, would affect unfairly the competitive position of other Bidders presenting substantially responsive Bids.
	27.3	The FBR will confirm that the documents and information specified under ITB 11, 12 and 13 have been provided in the Bid. If any of these documents or information is missing or is not provided in accordance with the Instructions to Bidders, the Bid shall be rejected.
	27.4	The FBR may waive off any minor informality, nonconformity, or irregularity in a Bid which does not constitute a material deviation, provided such waiver does not prejudice or affect the relative ranking of any Bidder. Explanation: <i>A minor informality, non-conformity or irregularity is one that is merely a matter of form and not of substance. 34. FBR's Right to reject All Bids	34.1	Notwithstanding ITB 32, the FBR reserves the right to reject all the bids, and to annul the Bidding process at any time prior to award of contract, without thereby incurring any liability to the affected Bidder or Bidders. However, the Authority (i.e. PPRA) may call from the FBR the justification of those grounds.
	34.2	Notice of the rejection of all Bids shall be given promptly to all Bidders that have submitted Bids.
	34.3	The FBR shall upon request communicate to any Bidder the grounds for its rejection of its Bids, but is not required to justify those grounds.

36. Notification of Award	36.1	Prior to the authorization, the FBR shall issue a Final Evaluation Report giving justification for acceptance or rejection of the bids.

	36.2	Where no complaints have been lodged, the Bidder(s) whose Bids have been accepted will be notified of the award by the FBR prior to expiration of the Bid Validity period in writing or electronic forms that provide record of the content of communication. The Letter of Acceptance will state the scope of works as prescribed by the license.
	36.3	The notification of award will constitute the formation of the Authorization, subject to the Bidder furnishing the Performance guarantee in accordance with ITB 38 and signing of the authorization in accordance with ITB 37.2 .
	36.4	Upon the successful Bidder's furnishing of the performance guarantee pursuant to ITB 38 , the FBR will promptly notify each unsuccessful Bidder, the name of the successful Bidder(s) and will discharge the Bid Security or Bid Securing Declaration of the Bidders pursuant to ITB 16.7 .
37. Signing of Contract	37.1	Promptly after notification of award, FBR shall send the successful Bidder the draft agreement, incorporating all terms and conditions as agreed by the parties to the contract.
	37.2	Immediately after the Redressal of grievance by the GRC, and after fulfillment of all conditions precedent of the Contract Form, the successful Bidder and the FBR shall sign the contract.
38. SECTION III: BID DATA SHEET

The instant procurement for authorized vendors is being conducted under the PPRA Ordinance, 2002 (as amended) and the Public Procurement Rules, 2004 read with PPRA Public Procurement Framework. The authorization is aligned with the provisions of public procurement as outlined in Section 2(1) of the PPRA Ordinance, which states:

““public procurement” means acquisition of goods, services or construction of any works financed wholly or partly out of the public fund and includes disposal of public assets and commercial transactions between procuring agency and private party, in terms of which the private party is allowed to-

- (i) perform a procuring agency’s assigned functions, including operations and management, on its behalf;*
- (ii) assume the use of public asset; or*
- (iii) receive a benefit either from budget or revenue of the Federal Government or from fees or charges to be collected by the private party for performing the procuring agency’s function or any combination thereof;”*

Furthermore, the entire procurement structure has been designed in accordance with Rule 4 of PPR, 2004, to ensure fairness, transparency, value for money, and efficiency. The rule states:

“4. Principles of procurements- Procuring agencies, while engaging in procurements, shall ensure that the procurements are conducted in a fair and transparent manner, the object of procurement brings value for money to the agency and the procurement process is efficient and economical”.

Since the proposed arrangement involves a variety of solutions across the system, it incorporates the broadest possible specifications as per Rule 10 of PPR, 2004. Accordingly, the entire procurement process and structure align with these principles and the relevant provisions of PPR, 2004, including but not limited to Rules 15, 21, 23, 29, and associated rules. The translation of these provisions has been included in the bidding document. To accommodate the scale of the industry and prevent exclusivity with a single authorized vendor (while expediting implementation), multiple authorized vendors are being engaged to promote competition and provide businesses the opportunity to work with various eligible vendors.

The following specific data for introducing a range of Authorized Vendors for Supply, Installation and Maintenance of Production Monitoring System in Hatcheries Sector (including hardware and software) for production monitoring shall complement, supplement, or amend the provisions in the Instructions to Bidders (ITBs). Whenever there is a conflict, the provisions herein shall prevail over those in ITBs.

Definitions: In this bidding document, unless there is anything repugnant in the subject or context;

- a. **“FBR” or “Board”** refers to the Federal Board of Revenue, responsible for authorizing vendors to deploy the specified system and ensuring compliance with the technical and operational requirements specified in this RFP
- b. **“Authorized vendor” or “Vendor” or “Supplier”** refers to any registered company authorized by the Board to deploy a production monitoring system specified by FBR after solution is finalized.
- c. **“ Poultry Hatchery Facility”** refers to any industrial facility engaged in the incubation, hatching, processing, and dispatch of day-old chicks (DOCs). This includes broiler

hatcheries, layer hatcheries, breeder-attached hatcheries, and integrated breeder–hatchery operations.

It encompasses all functional zones from egg receiving and storage, incubation (setters), hatching (hatchers), chick processing, grading, packing, and dispatch, up to the final transfer of chicks to delivery vehicles or designated dispatch areas.

- d. **"Packing/Dispatch Point"** refers to the designated location within a poultry hatchery where standardized trays, boxes or crates containing Day-Old Chicks are packed, verified and/or prepared for dispatch and where the production monitoring system shall automatically record each verified production event.
- e. **"Installation Point"** refers to the specific physical location at the designated packing/dispatch stage where the Box/Tray/Crate-Based Verification Solution, including cameras, verification devices, edge devices, sensors, computing and communication equipment, is installed to identify and verify each production container and determine the corresponding DOC quantity.
- f. **"Verification Device"** refers to the industrial-grade hardware and associated software used to automatically identify and verify standardized chick trays, boxes or crates. The verification mechanism may utilize industrial IP cameras, barcode/QR readers, RFID, optical recognition, machine vision or an equivalent validated technology capable of meeting the prescribed performance requirements.
- g. **"Packing Configuration"** refers to the approved configuration maintained in the system which specifies the corresponding number of Day-Old Chicks associated with each standardized tray, box or crate or other approved packing unit.
- h. **"Production Record"** refers to the system-generated record of each verified tray, box or crate, including the date/time, hatchery/site, installation point, container identifier where available, applicable packing configuration, corresponding DOC quantity, system/device identifier and other information prescribed by FBR.
- i. **"Hatcher" (Hatching Cabinet)** refers to the specialized incubation equipment in which fertile eggs, transferred from setters, complete the final stage of incubation and hatch into live day-old chicks under controlled temperature, humidity, and ventilation conditions.
- j. **"Chick Counting Module (CCM)"** refers to the hardware and associated embedded systems (industrial cameras, optical/weight sensors, lighting, processing units) designed to detect and count trays of day-old chicks in real time as they pass through the designated Installation Point, without requiring individual chick-level detection. The CCM must be capable of operating at commercial hatchery throughput speeds without causing stress, injury, or mortality to the chicks.
- k. **"Vision Verification System"** refers to the optical inspection hardware (industrial-grade cameras and lighting) and associated software algorithms used to validate the accuracy of chick counts by validating tray counts and tray completeness/integrity (e.g., confirming a tray is present, not empty, not a duplicate/re-pass) rather than validating individual chick detection accuracy.
It acts as the "Auditor", verifying that the counted chicks match the hatch output before packaging and dispatch.

- l. **"Production Count"** refers to the final verified production quantity of day-old chicks (DOCs), determined through the physical verification of trays, boxes or crates at the designated packing/dispatch point. The Production Count shall be calculated based on: (i)

identification and verification of each tray, box or crate; (ii) confirmation of valid and non-duplicate movement through the designated counting point; and (iii) application of the approved standard packing configuration/capacity applicable to the relevant chick category to determine the corresponding number of DOCs.

Only trays, boxes or crates successfully verified by the system and recorded as valid, non-duplicate production events shall be included in the final Production Count.

- m. **"Pro Pro-Hostile Operational Environment"** refers to the mandatory industrial and bio-secure conditions that the installed hardware must withstand within a commercial poultry hatchery. In the context of a hatchery facility, this includes operating zones characterized by:

Ambient Temperature: Typically ranging between 30°C to 40°C, with localized higher temperatures near hatcher

Humidity: Sustained high relative humidity (often exceeding 70%)

Contaminants: Presence of organic dust, feathers, fluff, disinfectant aerosols, and biological residues

Biosecurity Constraints: Frequent wash-downs, chemical sanitation, and restricted access protocols

Operational Stress: Continuous operation, vibration from conveyors, and high-throughput chick movement

All deployed equipment must be industrial-grade, bio-safe, corrosion-resistant, and suitable for continuous operation in such environments.

The procurement is being undertaken under the **Second Stage of the Two-Stage Bidding Procedure** prescribed under the Public Procurement Rules, 2004.

The First Stage of the procurement has been completed, wherein the technical proposals submitted by the eligible bidders were evaluated, Proof of Concepts (POCs) were conducted at designated hatchery facilities, and the Federal Board of Revenue (FBR) finalized the standardized Production Monitoring and Day-Old Chick (DOC) Counting Solution for implementation across the commercial poultry hatchery sector.

Accordingly, this Revised Request for Proposals (RFP) is issued only to the bidders who qualified the First Stage.

Eligible bidders shall submit:

- Revised Technical Proposals demonstrating compliance with the finalized technical specifications prescribed in this RFP;
- Revised or Supplementary Financial Proposals in accordance with the PPRA Rules, indicating the price per installation point together with the detailed component-wise cost of the finalized solution.

The revised proposals shall be evaluated in accordance with the evaluation criteria specified in this RFP. Where considered necessary, FBR may require bidders to demonstrate the finalized solution at a designated hatchery facility solely for verification of compliance with the prescribed specifications.



Upon completion of the evaluation process, FBR shall issue Letters of Authorization to the successful bidders.

FBR reserves the right to determine the number of Authorized Vendors based on the overall evaluation results and operational requirements.

Authorized vendor(s) shall have all required equipment (both hardware and software) readily available to enable timely deployment of the required production monitoring and day-old chick (DOC) counting system across commercial poultry hatchery facilities in Pakistan.

B. TECHNICAL REQUIREMENT

A. Background	
01.	The Federal Board of Revenue (FBR) is undertaking a significant digitalization initiative aimed at enhancing its tax collection capabilities and addressing structural gaps in Pakistan’s tax system. As part of this transformation, FBR seeks to deploy a production monitoring and day-old chick (DOC) counting system at all commercial poultry hatchery facilities in Pakistan (including broiler hatcheries, layer hatcheries, and integrated breeder–hatchery operations) to improve tax compliance and prevent revenue leakage within the sector, particularly in relation to the production, processing, and clearance of day-old chicks. As part of the authorization arrangement, selected vendors shall be responsible for supplying and installing a production monitoring and counting system (AI-based Vision Analytics for Tray Counting and Verification (as an approximation of Day-Old Chick output), or equivalent validated technologies). Vendors shall also be responsible for providing post-installation maintenance and technical support services to the hatchery operators. FBR recognizes the critical role of technology in addressing challenges related to tax evasion, under-reporting of production, and discrepancies in hatchery output data. This production monitoring initiative aims to deliver real-time visibility into the total production of day-old chicks across the hatchery sector. The proposed solution shall enable FBR to monitor and reconcile production counts, ensuring accurate reporting, transparent audits, and correct tax treatment of hatchery output. To promote competition, scalability, and non-exclusivity, a panel of multiple authorized vendors shall be established, providing hatchery operators access to a pool of qualified and competitive technology providers.

B. Business Functions and Performance Requirement

01. Business Requirements to Be Met by the Information System

The solution specified in this bid document shall detect, count, and record production units, namely day-old chicks (DOCs) (e.g., broiler chicks, layer chicks, or other commercial categories, as applicable) at the designated Installation Point, reporting the number of chicks produced per category, batch, or production cycle at commercial poultry hatchery facilities.

The system shall store the recorded production data on a local server or Industrial PC and securely transmit the data to FBR's system in near real time or at defined intervals, as specified in the RFP.

FBR shall have direct access to the production data through an interactive dashboard. Authorized users shall be able to filter and analyze data by parameters including, but not limited to:

- Chick Category / Product Type (e.g., broiler or layer)
- Time frame (shift, day, batch, hatch cycle, or period)
- Hatchery identification details (e.g., facility/site, hatcher ID, chick processing line, or batch number)

The dashboard shall enable FBR to analyze production trends, perform reconciliation and comparative analysis, and compare system-recorded production figures with quantities reported by the hatchery operator, supporting transparent audits and accurate tax assessment.

The solution comprises the following components:

a. Capture data:

The system shall automatically capture production data at the designated packing/dispatch station by verifying each standardized chick tray, box, or crate. The verification mechanism shall accurately identify every production unit and determine the corresponding number of day-old chicks based on the approved packing configuration prescribed by FBR. The system shall ensure that each production event is uniquely recorded and protected against duplicate or erroneous entries.

b. Ingest, transform, and load data:

The captured data shall be processed through a local processing unit or Industrial PC (IPC), which shall assign a unique transaction record with date and time stamps, validate the captured information, eliminate duplicate records, and prepare the data for secure transmission. The system shall maintain complete audit trails of all production events and system activities.

c. Store data:

The processed database shall be stored locally on the IPC for a defined buffer period, as specified by FBR, to ensure data integrity, redundancy, and continuity in the event of connectivity interruptions.

d. Connect data:

The data shall be securely transmitted to an internet-based instance, such as a central server or cloud-based application designated by FBR. Internet connectivity shall be provided by the hatchery facility. The system shall incorporate cybersecurity controls mandated by FBR, including but not limited to VPN-based secure access, encryption, and authenticated communication channels.

e. Visualize data:

A user-friendly interface and dashboard shall be provided, featuring interactive filters and controls enabling authorized users to view and analyze data based on parameters such as time frame (batch, shift, day, or period), hatchery/site, hatcher ID, chick processing line, or chick category.

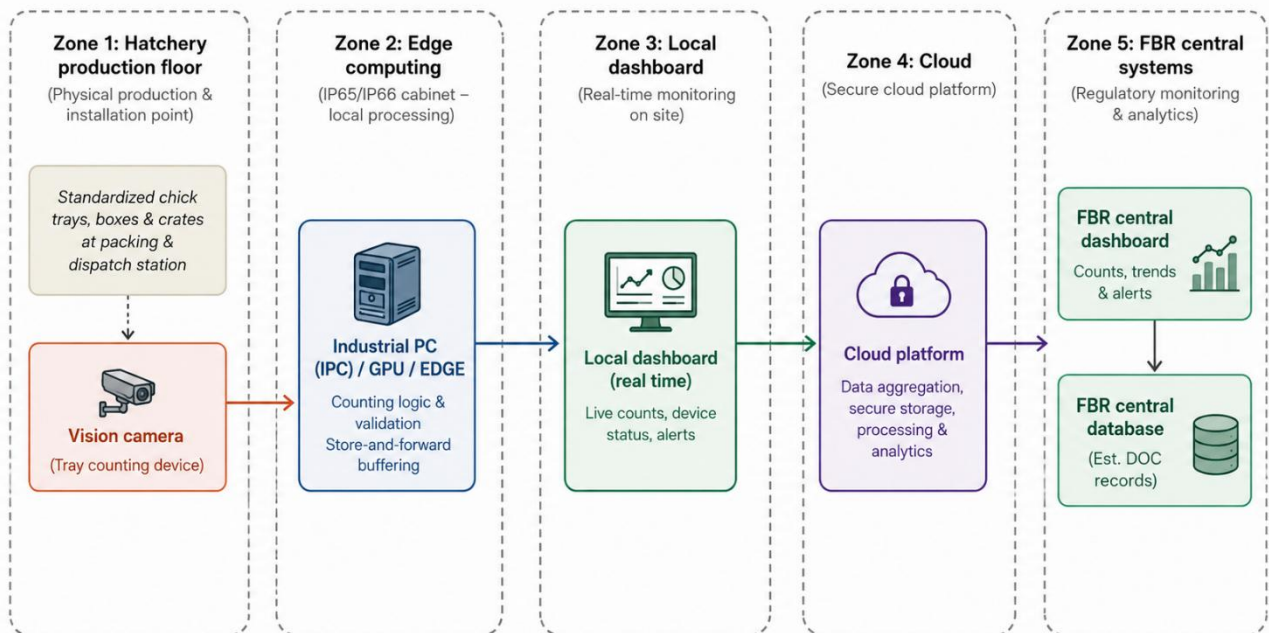


Figure A. High-level overview of technical architecture

Note: The bidder may propose a fully integrated, turnkey solution whereby a single prime vendor assumes end-to-end accountability for the entire system lifecycle, from deployment of hardware (including industrial vision cameras, hatch-cycle sensors, counting modules, and Industrial PCs) through to secure transmission of production data to FBR's systems.

Any such proposed architecture shall constitute a unified and cohesive ecosystem, seamlessly integrating industrial-grade detection and counting mechanisms with secure software and data interfaces, delivered as a ready-to-use solution without material reliance on fragmented or loosely coupled third-party components.

Bidders shall be required to demonstrate a holistic system design that ensures data integrity, continuity, and auditability from the installation point within the hatchery (e.g., hatcher discharge or chick processing line) directly through to the FBR dashboard, providing a single point of responsibility for installation, system integration, ongoing maintenance, and support.

The system shall incorporate appropriate event-triggering and validation mechanisms to ensure that each tray, box or crate passing through the designated verification point is recorded once and only once and that non-production movements, duplicate detections, test events or other irrelevant activities are not incorrectly recorded as production.

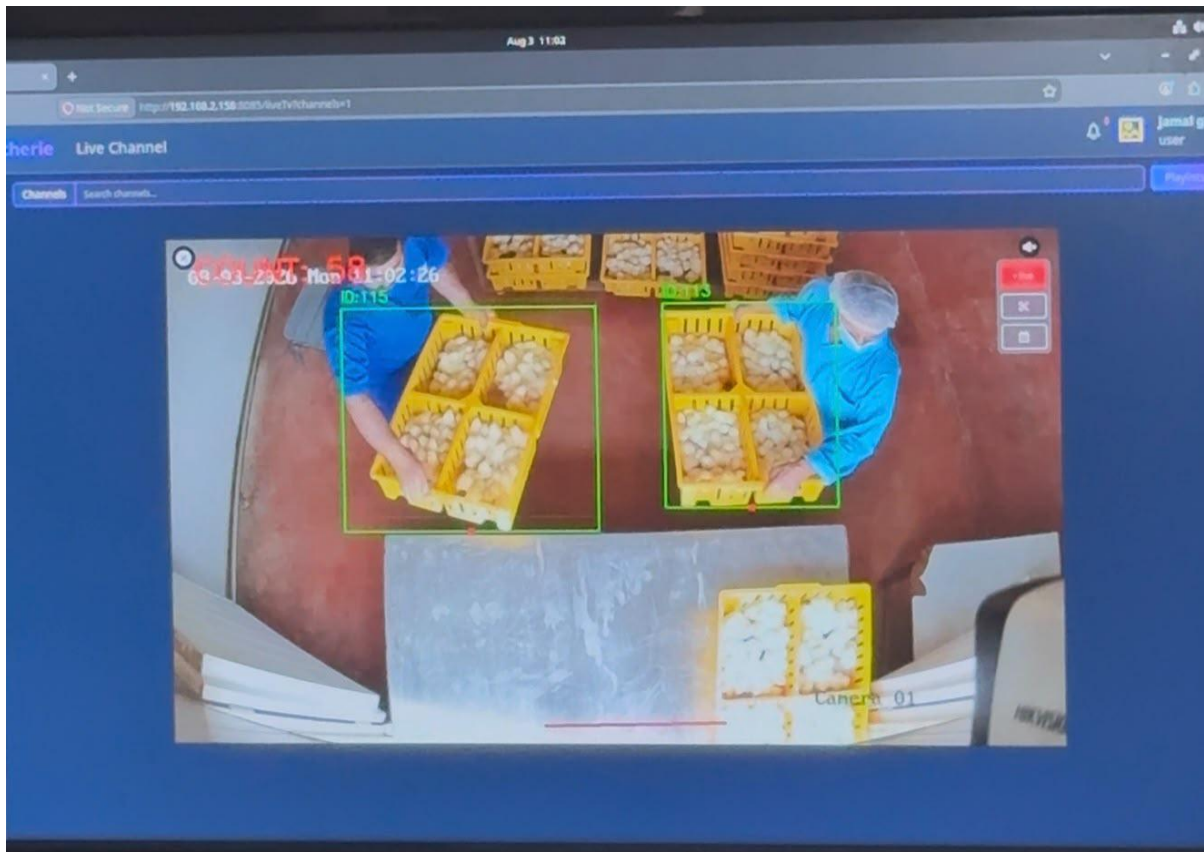

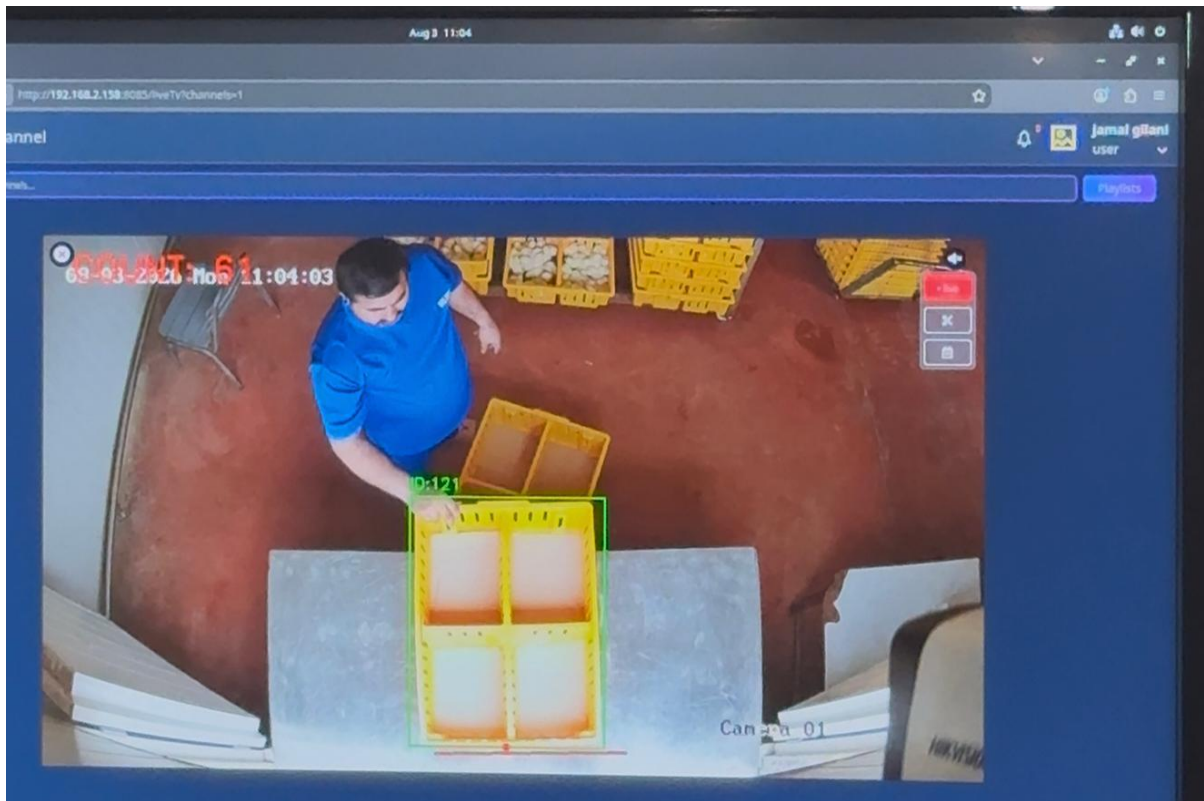

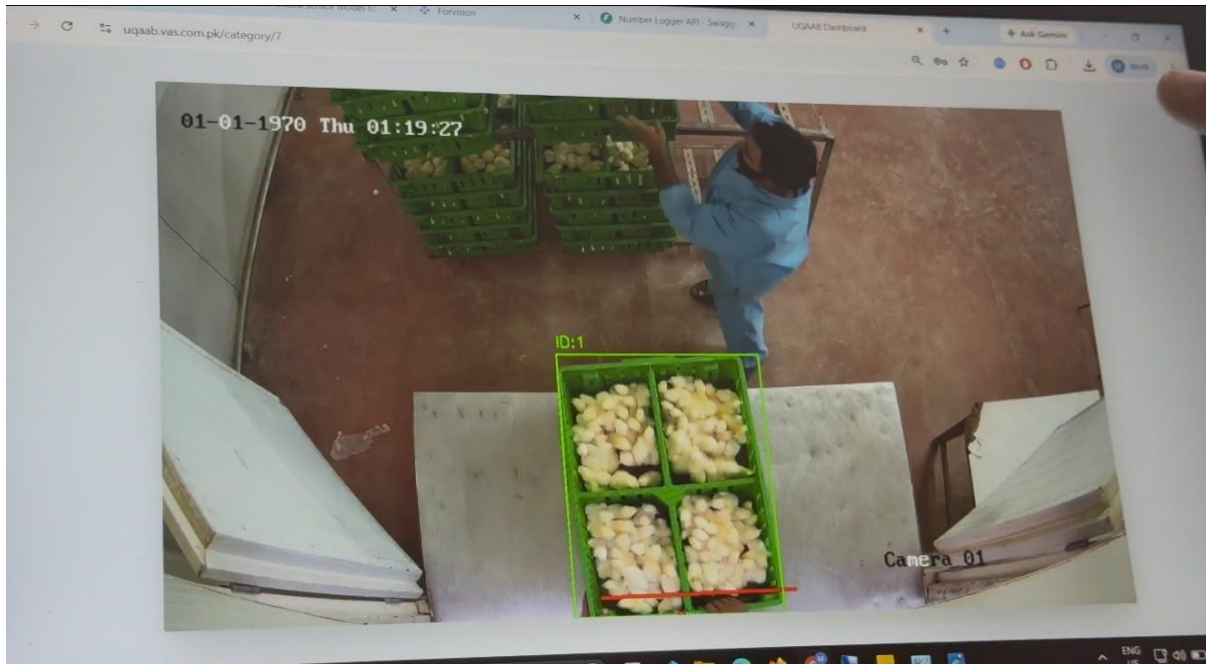
Video analytics should be able to detect stacked trays
