2. Firms must fulfill the following requirements:

- Sealed bids/offers are invited for the auction of condemned items. Bid containing necessary documents, CDR, Bidding Documents duly completed in all aspects shall be submitted on EPAD Ver. 2.0 uptill 07 OCT 2026 05:00 PM.
- Bid Security of un-successful bidders shall be released, once bid is awarded to successful bidder on next working day.
- The items can be inspected by interested bidders at the Custom House Building, Sector G-9/1, Islamabad on any working day from publication of auction notice during office hours till the auction date and time.
- The auction will be conducted strictly on an "As is, Where is" basis. The department holds no responsibility regarding the exact weight, condition, or measurement beyond physical inspection.
- The respective bid security against each item as mentioned in EPADS 2.0 must be deposited in original form before closing time in the office of "Deputy Collector, Collectorate of Customs Enforcement, Islamabad" Customs House, 24-Mauve Area, G-9/1, Islamabad on or before 07 Oct 2026 not later than 05 :00 PM.
- The bids will be opened on same day 07 oct 2026 at 05 30 PM at Customs House, 24-Mauve Area, G-9/1, Islamabad.
- On completion of auction process, successful bidder shall deposit 25% of the total bid amount in the shape of Pay order/ bankers check/ CDR or in cash within 2 working days in the office of collectorate of custom. Remaining 75% amount will be deposited in the in the shape of Pay order/ bankers check/ CDR within 7 days of the issuance of letter of acceptance. (*In case of failure to deposit, bid security shall be forfeited).
- The bidder shall quote their rates inclusive of all Govt applicable taxes.
- Successful bidder shall be responsible to pull out all items etc. from Customs House, 24-Mauve Area, G-9/1, Islamabad within 7 days after depositing of total amount, at their own expenses.
- The competent authority reserves the right to reject all bids / tenders without assigning any reasons as per PPRA Rule - 33

- Bid with incomplete / fake supporting documents will not be entertained, and furnishing of incorrect information shall be liable to legal action.
- If the successful bidder(s) fails to remove the stores within stipulated period, Customs has the right to charge demurrage to the bidder @ 2% per day of the total bid amount.
