IMPORTANT INSTRUCTIONS

- Detailed Bidding Documents, including lot-wise specifications, Schedule of Requirements, qualification requirements, lot-wise bid security amounts and terms & conditions, are available free of cost through EPADS 2.0, the PPRA website, and FBR's website.
- Only firms/suppliers holding valid NTN and STRN/GST registration (as applicable), meeting the qualification criteria specified in the Bidding Documents, and not blacklisted/debarred by any procuring agency or PPRA, shall be eligible to participate.

3. A bidder may submit bids for one, several, or all four lots. Each lot shall be bid upon, evaluated and awarded independently, with a separate bid security furnished for each lot bid upon. Partial or split bids within a single lot (i.e., offering only selected items of that lot) shall be treated as non-responsive for that lot.
4. Quantities indicated in the Schedule of Requirements are indicative annual estimates only; actual supplies against each lot shall be released through Call-Off/ Purchase Orders on an as-and-when-required basis during the currency of the respective Closed Framework Agreement, without any guarantee of minimum order quantity.
5. Prices quoted shall remain valid and fixed for the entire term of the respective Closed Framework Agreement, inclusive of all applicable duties, taxes, transportation and delivery costs up to Custom House, Islamabad, unless price adjustment is expressly permitted under the Bidding Documents in line with Rule 16B.
6. The Procuring Agency reserves the right to reject any or all bids, for any or all lots, at any time prior to acceptance, in accordance with Rule 33 of the Public Procurement Rules, 2004.
7. A Grievance Redressal Committee, constituted under Rule 48 of the Public Procurement Rules, 2004, is available on EPADS 2.0 for redressal of bidder grievances.
8. All other terms and conditions shall be governed by the Public Procurement Rules, 2004 (as amended), applicable PPRA regulations/guidelines, and the Bidding Documents.
