(SALES TAX)

S.R.O.18(I)/2007-. In exercise of the powers conferred by clause (c) of section 4 of the Sales Tax Act, 1990, the Federal Government is pleased to direct that the following further amendments shall be made in its Notification No. S.R.O.536(I)/2006, dated the 5<sup>th</sup> June, 2006, namely:-
