S.R.O.348(I)/2007.-In exercise of the powers conferred by clause (c) of section 4 of the Sales Tax Act, 1990, the Federal Government is pleased to direct that the following further amendments shall be made in its Notification No.S.R.O.527(I)/2006, dated the 5th June, 2006, namely:-
